Poster Guidelines: Your poster presentation should be related to nursing education, although clinical studies that advance the art or science of evidence-based nursing will be considered. Of special interest are abstracts that address special learning needs of nursing students, creative clinical experiences, student success strategies, clinical simulation, pharmacology teaching ideas, and e-learning. Abstracts will be peer-reviewed.

Guidelines for submission

Please email Deanne (Deanne@deanneblach.com) your abstract as a **Word® document** and include the information below. ****Submit the document as an attachment. Save the abstract as: (Your last name author)_Your Poster Title Here**

- ◇ Title
- ◇ Author(s) and contact information - include all authors' names, credentials, and titles as you would like them to appear in the conference notebook
- ◇ Summary of project or study methodology
- ◇ Limitations/Conclusions
- ◇ Implications for nursing educational practice
- ◇ Bibliography
- ◇ Include one learning outcome – a measureable outcome you expect the learner to obtain after you have a discussion with him/her about your work. Please use a measurable objective.

For example: *After reviewing this poster, the attendee will be able to:*

Apply the evidence into nursing practice.

Apply the updated criteria to the implementation of ...

Plan a high quality activity that incorporates....

Prepare a

Evaluate....

Any submissions that do not meet the required guidelines will not be accepted for review.

1. E-mail your abstract information to deanne@deanneblach.com or submit online at <http://www.deanneblach.com/posters>
2. You will be contacted regarding your submission within 2 weeks. If this time elapses, please contact Deanne. Check your email, including the “junk” box...sometimes the confirmation ends up here 😊.
3. More than one abstract may be submitted from an author/group of authors.
4. Students are encouraged to submit poster abstracts.
5. Poster titles and authors will be printed in the conference notebook.

6. Presenters at the conference will receive a poster presentation certificate.
7. You must be a registered attendee in order to participate as a poster presenter.
8. You will be provided with a draped table approximately 6' by 18" for your poster.
9. Prepare your poster to stand alone as a table top display or you can place Velcro on the back of your laminated poster and it can be stuck to the air wall in the conference room.
 - OPTION 1 - There will be no wall or backdrop on which to lean or hang your poster.
 - If necessary, Branson has office supply stores so you may purchase your backdrop support once you arrive at the conference.
 - Please do not ask the staff to obtain your poster board.
 - The exact size of the poster doesn't matter – it needs to fit on a 6' x 2' table.
 - OPTION 2 – you can bring a poster that has Velcro strips already attached to the back of your poster.
 - The poster will be applied directly to one of the air walls in the conference room.
 - The exact size of your poster does not matter.
 - YOU must provide your own Velcro strips. Velcro strips will not be provided.
10. Presenters are expected to be available for questions and discussion with participants during posted exhibit/poster session hours. Handouts and your contact information are recommended for attendees but not required.
11. Poster exhibit times are the same times as exhibit hall and break times which are outlined in the brochure.
